SUMMARY OF PROGRAM-RELATED INVESTMENTS:

ArtPrize Grand Rapids

The Dick and Betsy DeVos Family Foundation ("Foundation") has made a no-interest loan to ArtPrize Grand Rapids to provide funds to assist in the organization and operations of the 2012 ArtPrize competition and exhibition in Grand Rapids, Michigan in September and October 2012.

A promissory note of \$1,000,000 was executed on April 22, 2009, which was amended on August 24, 2009 and increased to \$1,700,000. On March 1, 2010 the promissory note was restated to \$4,000,000. The note was restated again on March 1, 2011 to the amount of \$5,200,000 and also on March 1, 2012 to the amount of \$5,400,000.

During 2012, \$350,000 was borrowed by ArtPrize on this promissory note and a partial forgiveness of the note was granted in the amount of \$108,295. The outstanding balance of the note as of December 31, 2012 was \$3,806,705.

The ArtPrize competition and exhibition is a radically open international art competition which awards the world's largest art prizes totaling \$560,000. Located in Grand Rapids, Michigan, the competition lasts two weeks and \$360,000 in prize money is awarded solely by public voting while \$200,000 in prize money is awarded by a juried vote. The Dick & Betsy DeVos Family Foundation paid \$460,000 of the 2012 prizes.

The ArtPrize competition and exhibition is considered to be part arts festival and part social experiment and creates an environment where people are inspired to go from imagining to making and doing. Its mission begins with the value that art is important. From that statement the ArtPrize competition and exhibition seeks to be a catalyst for collisions and connections between artists and communities for the sake of infusing vitality and courage into culture.
